**FIRST:** The corporate name that satisfies the requirements of Section 607.0401 is:

Milestone Classivision, Inc.

**SECOND:** The street address of the initial principal office and, if different, the mailing address of the Corporation is:

9500 Koger Boulevard

St. Petersburg, Florida 33702

**THIRD:** The number of shares the Corporation is authorized to issue is:

Ten Thousand (10,000) shares

**FOURTH:** (a) If the shares are to be divided into classes, the designation of each class is:

2,000 shares Common stock, one dollar (\$1.00) par value per share)

8,000 shares Preferred stock, one hundred dollars (\$100) par value per share

(b) Statement of the preferences, limitations and relative rights in respect of the shares of each class:

Preferred stock shall have a liquidation preference equal to \$100 per share. No dividends or distributions shall be paid in respect of common stock until distributions of 100 per share have been made in respect of outstanding shares of preferred stock.

Thereafter, distributions and dividends will be allocated 87.5% to preferred stock and 12.5% to common stock, until total distributions and dividends in respect of outstanding shares of preferred stock equal \$175 per share.

Thereafter, preferred stock shall have no further participation in distributions or dividends or any other assets of the corporation. Preferred stock shall have no voting rights.

FIFTH: Provisions granting preemptive rights are:

No preemptive rights.

SIXTH: The street address of the initial registered office of the corporation is 9500 Kroger Boulevard, Suite 226, St. Petersburg, Florida 33702, and the name of its initial registered agent at such address is Thomas H. Engel.
