ARTICLES OF INCORPORATION
OF
SHERRY PROPERTIES, INC.

ARTICLE I. CORPORATE NAME.

The name of this corporation is SHERRY PROPERTIES, INC.

ARTICLE II. PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation is 6 Vista Palm Lane, Unit 106, Vero Beach, Florida 32962.

ARTICLE III. CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 60 shares of no par value stock.

ARTICLE IX. RESTRICTIONS ON TRANSFER OF STOCK.


