The undereigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Plorida.

ARTICLE I. - NAME

The name of the corporation is SHORUGH TRADERS, INC.

ARTICLE II. - PURPOSE
