**ARTICLE I - NAME**

The name of the corporation is: HUNTER NATIONAL, INC.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence, unless sooner dissolved according to law.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares which this corporation is authorized to issue is one thousand (1,000) shares of common stock having a par value of \$.01 each, and shall be designated "common shares"

**ARTICLE V - SHAREHOLDERS HOLDINGS**

The number of common shares initially held are:

**ARTICLE VI - PRE-EMPTIVE RIGHTS**

Every shareholder, upon the sale (by this corporation) for cash or property of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his or her pro rata share thereof, as nearly as may be done without issuance of fractional shares, at the price per share at

which it is offered to others based on cash value or fair market value of property involved in the sale.
