

OF

The undersigned subscribers to these Articles of Incorporation, being natural persons competent to contract and acting as an incorporator to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the Corporation shall be VARNES TRUCKING, INC.

ARTICLE II

This corporation is to exist perpetually, commencing upon the filing of these Articles.

ARTICLE III

The purpose of this corporation is to engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Thousand (1000) shares of no par value.




ARTICLE IX



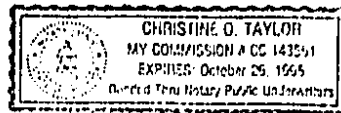
