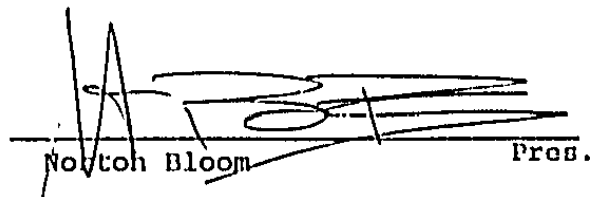
ARTICLES IX - INDEMNIFICATION

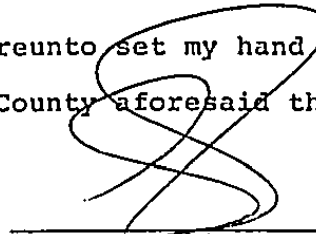

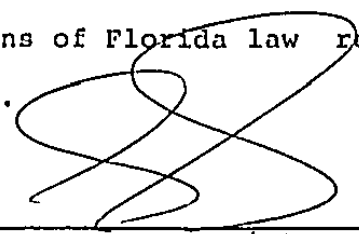
