ARTICLES OF INCORPORATION
OF
DESIGN OPTIONS, INC.

ARTICLE I
CORPORATE NAME AND PRINCIPAL ADDRESS

The name of this corporation is Design Options, Inc., and the initial principal address of the corporation is 405 Roanoke Street, Dunedin, FL 34698.

ARTICLE II
NATURE OF BUSINESS AND POWERS

The general nature of the business transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III
CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV
TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE V
REGISTERED AGENT, INITIAL REGISTERED OFFICE
