ARTICLE I

NAME

The name of the corporation is

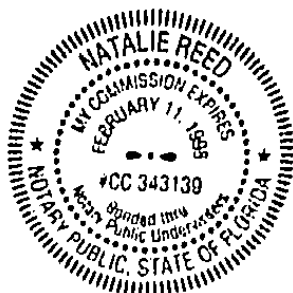


