ARTICLE I - NAME. The name of this corporation is KEMANDA
COMMERCIAL INVESTMENTS, INC.

EFFECTIVE DATE
FEB 7 1995

ARTICLE II - DURATION. This corporation is to have perpetual
existence beginning with the date of subscription and
acknowledgment of these Articles of Incorporation which is February
7, 1995.

ARTICLE III - PURPOSE. This corporation is organized for the
purpose of engaging in any activity or business permitted under the
laws of the United States of America and of the State of Florida.

ARTICLE IV - CAPITAL STOCK. This corporation is authorized to
issue 1,000 shares of common stock at \$1.00 par value per share.

ARTICLE V - PREEMPTIVE RIGHTS. After the initial issue of common
stock by this corporation, every shareholder, upon the sale for
cash or other property, whether tangible or intangible or for labor
or services actually performed for the corporation (the
Consideration) of any new stock of this corporation of the same
kind, class or series as that which he already holds shall have the
right to purchase his pro-rata share of the stock of this
corporation (as nearly as may be done without issuance of

(fractional shares) at the cash price determined by the Board of Directors at which time the stock would be issued to others for the consideration to be given by the other.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT. The street address of the initial registered office of this corporation is 6365 N. W. 6th Way, Suite 160, Fort Lauderdale, Florida 33309 and the name of the corporation's initial registered agent is DIVERSIFIED MANAGED INVESTMENTS, INC., a Florida corporation.

ARTICLE VII - PRINCIPAL OFFICE. The corporation's principal office and mailing address are 6365 N. W. 6th Way, Suite 160, Fort Lauderdale, Florida 33309.

ARTICLE VIII - FIRST BOARD OF DIRECTORS. This corporation's first Board of Directors shall consist of one Director. 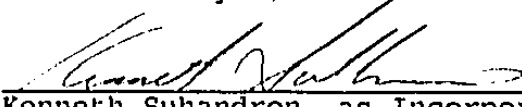

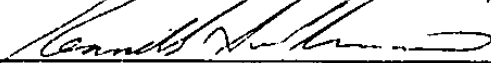
