ARTICLE I - NAME

The name of the corporation is Cubero Enterprises, Inc. The principle address of the corporation is: Post Office Box 014363, Miami, Florida 33101.

ARTICLE II - DURATION

The corporation is to exist perpetually.

ARTICLE III - PURPOSE

The purpose for which this corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
