#### ARTICLES OF INCORPORATION

OF

#### THE SIXTEENTH STREET CORPORATION

### Article I - Name

The name of the corporation is THE SIXTEENTH STREET CORPORATION and the principal office and mailing address is 2827 l6th Street North, St. Petersburg, Florida 33704.

#### Article II - Duration

This corporation shall exist perpetually.

#### Article III - Purpose
