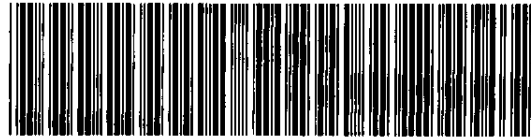

ARTICLE I

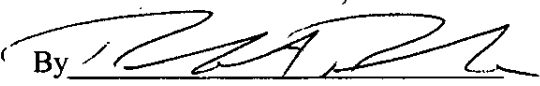
The name of the corporation is Soundside Office, Inc.

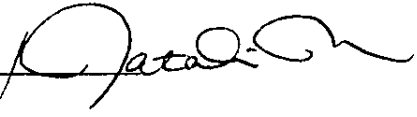

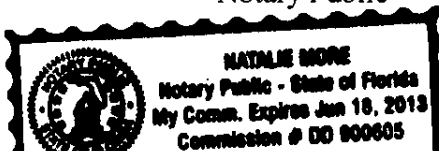
