The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the corporation is: PRODUCE CORNER, INC.

ARTICLE TWO

The general purposes for which the corporation is organized are:

- 1. To import, export, distribute wholesale and retail fresh and processed produce.
- 2.
