I. THE UNDERSIGNED SUBSCRIBER, agree to form a Corporation under the laws of the State of Florida and hereby make, subscribe, acknowledge and file these Articles of Incorporation as follows:

**ARTICLE I**

**NAME OF CORPORATION**

**DURATION OF CORPORATION**

This corporation shall exist perpetually unless dissolved according to Florida law.


interested in such contract or transaction with this corporation is hereby relieved from any liability that might exist from such contract or transaction of this corporation.


