ARTICLES OF INCORPORATION OF SALES EXPRESS, INC.

The undersigned, acting as the Incorporator of a corporation under the Florida Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of this corporation is SALES EXPRESS, INC..

ARTICLE II

The period of its duration is perpetual.
