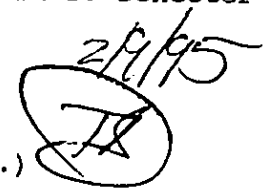

ARTICLE I - NAME

The name of this corporation is ADVANCEMENT SERVICES, INC.

ARTICLE II - DURATION

This corporation shall commence on the date of execution and acknowledgment of these Articles, on the 3 day of February, 1995. This corporation is to have perpetual existence unless sooner dissolved according to law.

ARTICLE III - PURPOSE

The name of the business and the objects and purposes to be transacted and carried on are to do any and all of the things hereinafter mentioned, as fully and to the same extent that natural persons might or could do, viz:

- a. To assist students in the location of college scholarship opportunities.

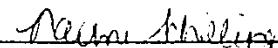

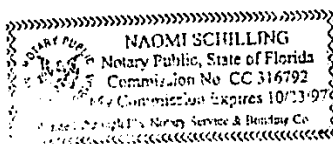
