

ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE 1

The name of the Corporation (which is hereafter called the "Corporation") is EASTERN ATLANTIC SERVICES, INC.

ARTICLE II

The principal place of business and mailing address of this Corporation shall be: 1100 Deer Gulley Court, Apopka, Florida 32712.

ARTICLE III

The Corporation is authorized to issue one class of shares having a total number of One Thousand (1000) shares with a par value of \$ 1.00 per share.

ARTICLE IV

Such indemnification shall not be deemed exclusive of any other rights to which those indemnified may be entitled, under any By-Law, agreement, vote of stockholders or otherwise.
