. The undersigned, for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I

The name of this corporation shall be SONIC BOOM MUSIC, INC.

### ARTICLE II

The corporation shall have perpetual existence, unless sooner dissolved according to law.

## ARTICLE III

The general nature of the business or businesses to be transacted by this corporation shall be: to sell, trade, advise, and otherwise deal in any and all manner of compact discs, tapes, records, and all other forms of music;
