ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF CODI INDUSTRIES, INC.

Pursuant to the provisions of the Florida Business;
Corporation Act, the undersigned corporation adopts the following
Articles of Amendment to its Articles of Incorporation:

- 1. The current name of the Corporation is CODI INDUSTRIES, INC..
- 2.
