**ARTICLES OF INCORPORATION**

**OF**

**JAMES O. DRAKE, INC.**

I, the undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation.

**ARTICLE I: NAME**

The name of the corporation is: JAMES O. DRAKE, INC. The principal office and mailing address is: 1533 Hendry Street, 301, Fort Myers, Florida 33901.

**ARTICLE II: DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE III: PURPOSE**

The purpose for which the corporation is organized is for the conduct of private investigative services for attorneys and private citizens, service of legal process both civil and criminal, crime scene analysis and computer research.

The corporation may transact any and all lawful businesses for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE IV: CAPITAL STOCK**

The aggregate number of shares of stock which the corporation has authority to issue is FIVE HUNDRED (500), all of which shall be common shares with a par value of \$1.00.

**ARTICLE V: TERM OF EXISTENCE**

The corporation shall commence business as soon as the Secretary of State of the State of Florida approves and issues the

Charter and shall continue perpetually thereafter unless sooner dissolved by law.


**ARTICLE VI: INITIAL REGISTERED OFFICE**

The street address of the initial registered office of the corporation in the State of Florida is: 1533 Hendry Street, Suite 301, Fort Myers, Florida 33901.

**ARTICLE VII: INITIAL REGISTERED AGENT**

The initial registered agent of this corporation is: JAMES O. DRAKE, 1533 Hendry Street, suite 301, Fort Myers, Florida 33901

I, JAMES O. DRAKE, hereby accept the designation of registered agent of the above-named corporation.

**ARTICLE VIII: DIRECTORS**

This corporation shall have one (1) directors initially. The number may be increased from time to time by Bylaws adopted by the stockholders.

**ARTICLE IX: INITIAL DIRECTORS**

**ARTICLE X: INCORPORATORS**

**ARTICLE XI: PREEMPTIVE RIGHTS**

Shareholders of the corporation shall have preemptive rights to acquire their prorata share of stock of the corporation for all

issues of any class of stock of the corporation no matter when authorized or for whatever consideration it is contemplated to be received by the corporation including but not limited to cash, other properties, services, the acquisition of other corporation shares or property through merger or the extinguishment of debts. Preemptive rights shall apply to any issuance of shares and to the reissuance of all redeemed or otherwise acquired shares including the reissuance of treasury shares.


This Article pertaining to preemptive rights may not be amended or deleted except with the unanimous vote of the shareholders of each affected class.

No issuance of stock of the corporation shall take place unless the price at which the stock is to be issued shall be unanimously approved by the shareholders of the corporation. The preemptive rights shall apply to any corporate obligation which is convertible to or exchangeable for any stock of the corporation or where there is attached to said obligation any stock warrants or rights which allow the holder to acquire by subscription or purchase any stock of the corporation.

#### **ARTICLE XII: AMENDMENT**

The Articles of Incorporation may be amended in the manner provided by law. Each amendment shall be approved by the Board of Directors, proposed to them by the stockholders, and approved at a shareholders meeting by a majority of the stock entitled to vote thereon unless all Directors and all stockholders sign a written agreement manifesting their intention that a certain amendment to these Articles of Incorporation be made.


