ARTICLE | CORPORATE NAME

The name of the corporation shall be:

ARTICLE II NATURE OF BUSINESS AND COWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all businesses permitted under the laws of the State of Florida.

ARTICLE III CAPITAL STOCK
