ARTICLE 1 - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS

The name of the Corporation shall be **TAYLOR RESIN SYSTEMS, INC.** The principal and mailing address of the corporation shall be 6827 Acacia Court, Port Richey, Florida 34668.

ARTICLE II - CAPITAL STOCK

The Corporation is authorized to issue one thousand (1,000) shares of capital stock of the par value of one dollar (\$1.00) which shall be designated "Common Shares," and all of which shall have the same rights and privileges.

ARTICLE III - PRE-EMPTIVE RIGHTS


