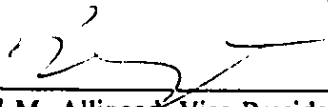

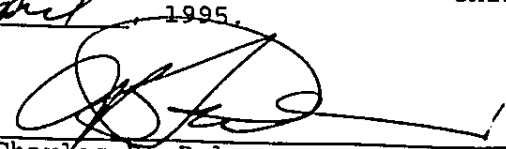
1. The name of the Corporation is RESCOM, INC.
