

ARTICLES OF INCORPORATION



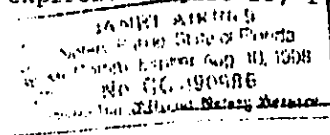
