The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I--NAME

The name of the corporation shall be , LOTT CONSTRUCTION CLEANUP, INC.

ARTICLE II -- NATURE OF BUSINESS

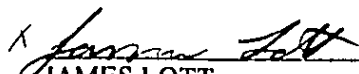
