ARTICLES OF INCORPORATION
OF
W. DALE BORDEN, INC.

THE UNDERSIGNED SUBSCRIBERS to these Articles of Incorporation, natural persons, competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I
NAME OF CORPORATION

The name of this corporation shall be W. DALE BORDEN, INC.

ARTICLE II
GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by the corporation is:
