ARTICLES OF INCORPORATION OF W. DALE BORDEN, INC.

THE UNDERSIGNED SUBSCRIBERS to these Articles. Incorporation, natural persons, competent to contract, hereby a corporation under the laws of the State of Florida.

ARTICLE I NAME OF CORPORATION
