The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "corporation") is AYAFI CONSULTANTS, INC.

FOUNTH: The number of shares that the corporation is authorized to issue is 1,000, all of which are with par value of 1.00 dollar each and are of the same class and are to be Common shares.
