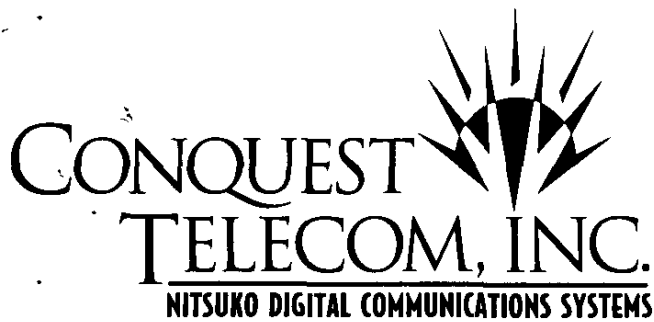

It has come to my attention that you have not received my payment by check sent to you in February of this year that renews our corporation status for 1999.

Due to the fact the original form with check #2584 was sent to you on February 22, 1999 (see attached enclosures); I feel that the late fee should be waived. Instead, I will "re" fill out the 2<sup>nd</sup> form and "re" write the check for the original \$150.00.

My proof to you of course, is not a cancelled check because you say you never received it and the corporate banking account (*First Union*) shows it was never cashed.

The busiest time of the year begins for our corporation in May and unfortunately, we also incurred several changes during this same time period which include; changing financial institutions to AmSouth, changing out our computer system (evolving from MacIntosh to PC due to the Y2k problem) and training a new office manager! This process of change was very pain staking and difficult as evidence in our lapse of accountability with closing the First Union account before making sure our check to you had cleared. Obviously, if this had not been overlooked, another check would have been issued immediately, avoiding any late fees. I do apologize and respectfully request that no late fees will be charged. Despite all the changes the corporation endured during that time period, I can assure you this lapse of control will not be repeated in the future.
