**ARTICLE I - NAME**

The name of this Corporation is **PATRICORP OF PRAIRIE POINT, INC.**

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE VI - INITIAL BOARD OF DIRECTORS**


