ARTICLES OF INCORPORATION

OF

DRIVING FORCE DISCOUNT AUTO INSURANCE, INC.

The undersigned, David F. Dickerson hereby executes this document for the purposes of becoming incorporated under the laws of the State of Florida, and forming a corporation under the following proposed Certificate of Incorporation:

ARTICLE I

The name of this corporation is Driving Force Discount Auto Insurance, Inc.

The general nature of the business to be transacted by the corporation is as follows:
