ARTICLES OF INCORPORATION OF JOHN M. STARLING, P.A.

SECRETARY OF STATE

The undersigned natural person, competent and licensed to practice law in the State of Florida, acting hereby as incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607 and Section 621, of the Florida statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be JOHN M. STARLING, P.A.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the filing of these Articles with the Secretary of State of the State of Florida.

ARTICLE III - PRINCIPAL OFFICE

ARTICLE IV - PURPOSES

The general nature and purposes of the business to be transacted and carried on by the corporation are as follows:
