FIRST. The name of the Corporation is Chevron Island Boat Rentals, Inc.

SECOND. Its registered office in the State of Florida is to be located at US1 MM25, in the city of Summerland Key, County of Monroe. The registered agent in charge thereof is Marquerite L Clarke at 88 Coral Drive, Sugarloaf Key, Florida 33042.

I heroby am familiar with and accept the duties and responsibilities as registered agent for Chevron Island Boat Rentals, Inc.

THIRD. The fiscal year of the corporation shall begin on the first day of January and end on the thirty-first day of December of each year.

FOURTH. The nature and objectives of the business is to produce, manufacture, purchase or otherwise acquire, sell, import, export, distribute and deal in goods, wares, merchandise and materials of any kind and description.

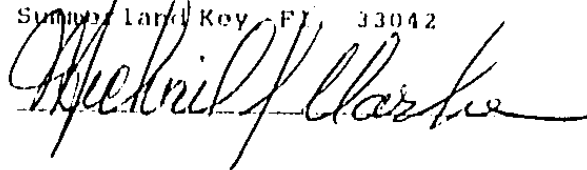

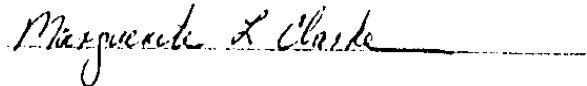
