The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME AND ADDRESS

The name of the corporation is SOUNDS OF IRELAND, INC. The principal address of the corporation is 4405 - 78th Lane North, St. Petersburg, Florida 33709.

ARTICLE TWO: DURATION

This corporation shall exist perpetually.

ARTICLE THREE: PURPOSE

This corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE FOUR: CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue is Seven Thousand Five Hundred (7,500), all of which shall be common shares having a Par Value of One and 0/100 Dollars (\$1.00) per share.

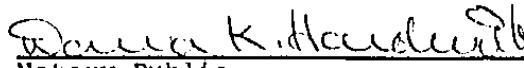

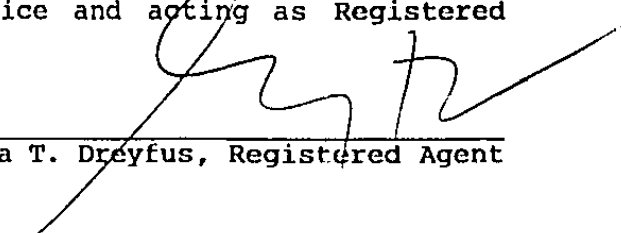
