ARTICLES OF INCORPORATION

ARTICLE I

NAME

The name of this corporation is HILMART TRUCKING, CORP.

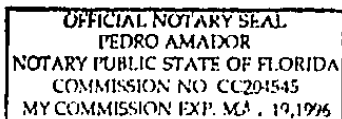
