### ARTICLES OF INCORPORATION

OF

## M F STARGATE, INC.

The undersigned subscriber, for the purposes of forming a corporation for profit under Chapter 607 of the laws of the Statoll of Florida, hereby subscribes to, acknowledges and files the following Articles of Incorporation.

The name of the proposed corporation shall be M F STARGATE, INC. Its initial address shall be 904 Bayshore Boulevard,, Port St. Lucie, FL 34983.

## ARTICLE 11

## Duration

This corporation shall commence existence on the date of the execution and acknowledgment of these Articles if permitted by law; if not, then on the date of filing. This corporation shall exist perpetually thereafter, unless sooner dissolved according to law.

## ARTICLE III

## Purpose

This corporation is formed for the following purposes and shall have the following powers:

- 1. ### ARTICLE IV

## Capltal Stock

This corporation is authorized to issue One Thousand Two Hundred shares (1,200) shares of One and No/100 Dellars (\$1.00) par value capital stock, which shall be designated as "common shares". The entire voting power for the election of directors and for all other purposes shall be in the holders of outstanding common shares.

All the shares of such common stock shall be paid for in cash, or property, real or personal, tangible, intangible, or the lease thereof,, or in labor or services in lieu of cash or property, at a just valuation to be fixed by the Board of Directors of this corporation unless otherwise forbidden by the laws of the State of Florida. The payment thereof does not have to be at the time of issuance, provided such shares are subject to calls thereon by the corporation until such time as the whole consideration therefore shall have been paid.

## Initial Registered Office and Agent

### **Rylaws**

In furtherance and not in limitation of the powers conferred by the laws of the State of Florida and the United States of America, the Board of Directors is expressly authorized to frame and adopt any such Bylaws for the corporation as are not inconsistent with the laws of the State of Florida or the United States of America or those Articles of Incorporation. With the exception of fixing the number of directors of the corporation, the Board of Directors is expressly authorized, without the assent of the stockholders, to add to, delete from or otherwise amend the Bylaws of the corporation.
