ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, acting as Incorporator of a corporation, under the Florida General Corporation Act, adopts the following Articles of Incorporation, for such Corporation:

- 1. The name of this Corporation is UNCLE LOU'S ORIGINAL HOAGIES, INC.
- 2. The period of duration of the Corporation is perpetual.
