ARTICLE I - NAME

The name of this corporation is Immediate Delivery, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on February 10, 1995.

ARTICLE III - PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 1,000 shares of one penny (\$0.01) par value common stock, which shall be designated "Common Shares."
