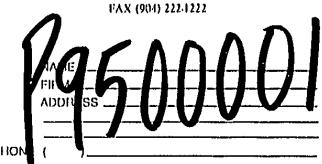

THE UNDERSIGNED, acting as sole incorporator of Pillows Direct, Inc., under Chapter 607 of the Florida Statutes, horeby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Office

The name of the corporation shall be Pillows Direct, Inc., and the corporate address shall be 4630 S. Kirkman Rd.; Suito 421; Orlando, FL 32811.

ARTICLE III

Duration

The duration of the corporation is perpetual.

ARTICLE III

General Purposes

The purpose of the corporation is to engage in any acts or activities for which a corporation may be organized under Chapter 607 of the Florida Statutes.
