ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is:

SOUTHERN GENERAL CONTRACTORS, INC.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:
