ARTICLES OF INCORPORATION

OF

CBS-COMPLETE BUSINESS SERVICES, INC.

The undersigned natural person, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE I. NAME.

The name of this corporation is: CBS-COMPLETE BUSINESS SERVICES, INC.

ARTICLE II. PRINCIPAL OFFICE.

The street address of the initial principal office of the corporation is 11 Trail Run, Flagler Beach, Florida 32136. ARTICLE III. DURATION.

The period of the corporation's duration shall be perpetual or until dissolved on a vote of the shareholders as hereafter provided.

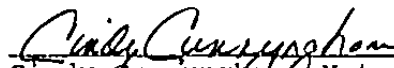
