

ARTICLES OF INCORPORATION

OF

KING ORIENTAL CARPETS AND RUGS, INC.

EFFECTIVE DATE
2-6-75

ARTICLE I - NAME

The name of the corporation is KING ORIENTAL CARPETS AND RUGS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 416 S. Washington Blvd., Sarasota, Florida 34236.

ARTICLE III - CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any time is 500 shares of common stock, each having zero (0) par value.

ARTICLE IV - REGISTERED AGENT

ARTICLE V - INCORPORATOR

ARTICLE VI - PRE-EMPTIVE RIGHTS

Every Shareholder, upon the sale for cash of any new stock of this Corporation, shall have the right to purchase his pro-

rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII -EXISTENCE

The Corporation shall commonce on February 6, 1995, and the corporation shall have perpetual existence.

ARTICLE VIII - PURPOSE

This Corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended

ARTICLE XI - AMENDMENT

This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any Amendment hereto, by a majority vote of the Board of Directors.

Any right conferred upon the Shareholders is subject to this

reservation.

ARTICLE XII - LIMITED LIABILITY

Shareholders shall not be personally liable for acts of the corporation.
