The undersigned, in order to form a corporation for the purposes hereinafter stated, by and under the provisions of the Statutes of the State of Florida, do hereby subscribe to these Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation is:

PLASTIC SERVICES UNLIMITED, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the following purposes:

d. To engage in any and all lawful activity and to institute, participate in and promote commorcial, mercantile, financial and industrial enterprises and operations, and for the purpose of transacting any or all lawful business.


