I, the undersigned subscriber to these Articles of Incorporation, a natural person competent to contract and an attorney duly licensed to render professional legal service in the State of Florida, desires to form a professional corporation under the laws of the State of Florida pursuant to the provisions of Chapter 607, and 621, of the Florida Statutes.

Article I - Corporate Name

The name of this corporation shall be RUSSELL BEYER, P.A.

Article II - Nature of Business

The general nature of the business to be transacted by this corporation is:

To engage in every phase and aspect of the business of rendering to the public the same professional services that an attorney duly licensed under the laws of the State of Florida is authorized to render, but such professional services shall be rendered only through the corporation's officers, employees and agents who are duly licensed or otherwise legally authorized under the laws of the State of Florida to practice law in such state;

To engage in other lawful business permitted under Florida law.

Article III - Capital Stock

The authorized capital stock of this corporation shall consist of 1,000 shares of common stock having a par value of \$1.00 per share. None of the shares of capital stock of this corporation may be issued to anyone other than an individual duly licensed or otherwise legally authorized to practice law in the State of Florida. The stock of the corporation shall be issued for such consideration as may be determined by the Board of Directors.

Article IV - Term of Existence

This corporation shall exist perpetually unless dissolved according to law.

Article V - Address of Principal Office

The street address of the principal office of this corporation in the State of Florida shall be 3015 North Ocean Blvd., Apt. 3H, Fort Lauderdale, Florida 33308. The Board of Directors may from time to time move the principal office to any other address in the State of Florida and may establish branch and other offices within the State of Florida.

Article VI - Number of Directors

This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time pursuant to the Bylaws, but shall never be less than one.

Article VII - First Board of Directors

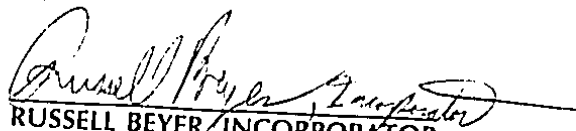
Article VIII - Incorporators
