

ARTICLES OF INCORPORATION  
OF

ARTICLE I.  
NAME

The name of the corporation is "CLEAN AS A WHISTLE MAID SERVICE, INC."

ARTICLE II.  
DURATION

This corporation shall have perpetual existence, commencing on the filing of these articles with the Department of State.

ARTICLE III.  
CAPITAL STOCK

This corporation is authorized to issue ONE THOUSAND (1000) shares of ONE DOLLAR (\$1.00) par value common stock.

ARTICLE IV.  
PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE V.  
PURPOSE

This corporation is organized for the business purpose of commercial and residential cleaning services and for the purpose of transacting any and all lawful business.

ARTICLE VII.


The principal office and the mailing address of this corporation is 6845 Pine Forest Road, Pensacola, Florida 32526.


