ARTICLES OF INCORPORATION
OF
LAS OLAS MANAGEMENT, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Las Olas Management, Inc.

ARTICLE II

MAILING ADDRESS

The mailing address of the corporation is 801 Brickell Avenue, 24th Floor, Miami, Florida 33131.

ARTICLE III

CAPITAL STOCK

The corporation shall indemnify any present or former officer or director, or person exercising powers and duties of an officer or a director, to the full extent now or hereafter permitted by law.
