ARTICLES OF INCORPORATION
OF
JOHN SANDY & ASSOCIATES, INC.

ARTICLE I - Name

The name of this corporation is JOHN SANDY & ASSOCIATES, INC.

ARTICLE II - Duration

The period of its duration is perpetual.

Principal Office and Mailing Address


The street address of the initial registered office, the principal office and mailing address of the corporation is 5175 SE 20th Street, Ocala, Florida 34471.


