ARTICLES OF INCORPORATION OF UNIVERSAL DISPLAY COMPANY

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

I. Name

The name of the Corporation is UNIVERSAL DISPLAY COMPANY.

II. Term of Existence

The date when corporate existence will commence is February 13, 1995 in accordance with the provisions of Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

III. Principal Office

The principal office and mailing address of the Corporation is 5830 Memorial Highway, #116, Tampa, Plorida 33615.

IV. Capital Stock

The Corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, which will be designated Common Stock.

V. Initial Registered Office and Agent

X. Bylaws

The Corporation will indemnify any director or officer or any former director or officer, to the fullest extent permitted by law.

XII. Amendment

These Articles of Incorporation may be amended in the manner provided by law.
