ARTICLES OF INCORPORATION

THE UNDERSIGNED, hereby executes these Articles of Incorporation for the purpose of becoming a corporation for profit, under the laws of the State of Florida, and I hereby certify that I have become such corporation under and pursuant to the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is " W. C. P. ENTERPRISES, INC., A FLORIDA CORPORATION"

ARTICLE II - PURPOSES

The purpose for which this corporation is to be formed, and the general nature of the business to be transacted by said corporation is:

(a) To engage in miscellaneous retail businesses including but not limited to used motorcycle/repairs and accessories and welding shop.

(b) To buy, hold, mortgage, sell, convey, lease or otherwise dispose of, real and personal property in the State of Florida and in all other states; to contract debts and borrow money, issue and sell or pledge bonds, debentures, notes or other evidences of indebtedness, and execute such mortgages, transfer of corporate property or other instruments to secure the payment of corporate indebtedness as required; to purchase the corporate assets of any other corporation and engage in the same or other character of business.

(c) To engage in any activity or business permitted under the Laws of the United States of America and of the state of Florida.

#### ARTICLE III - STOCK

The maximum number of shares of stock that this corporation shall have outstanding at any one time is, one hundred (100) shares of common stock, having a nominal or par value of Ten (\$10.00) Dollar per share.

#### ARTICLE IV - TERM OF EXISTENCE

This corporation shall have perpetual existence.

#### ARTICLE V - INITIAL REGISTERED OFFICE
