ARTICLES OF INCORPORATION OF

SOUTHERN MAPPING TECHNOLOGY, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name and Address

The name of the Corporation is Southern Mapping Technology, Inc. The principal office, if known, or the mailing address of the Corporation is 1020 Goodlette Frank Road, Suite 200(E), Naples, Florida 33940.

Article 2. Duration

The duration of the Corporation is perpetual.

Article 3. Purpose

The general purposes for which the Corporation is organized are the following:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
